### **Charging and Refund Procedures for Students:**

- Elementary schools: 3 meals maximum charge is allowed.
- Junior High Schools: 1 meal charge is allowed.
- High Schools: 1 meal charge is allowed.
- The student will be provided the lowest cost reimbursable meal (The Blue Plate Special) when they reach their limit. It will consist of a turkey and cheese sandwich, vegetable, fruit, and a milk of their choice.
- When a student has been provided an alternate meal 3 consecutive times the principals' office will be notified.
- Contact the Nutrition Dept. for any special circumstances if a student reaches their charging limit or a parent paid on-line.
- Beginning in May of each school year, only 2 meal charges will be allowed for Elementary School students and 1 meal charge will be allowed for Junior High and High School students until the end of the school year, in order to keep negative balances at a minimum. Cafeteria staff will try to collect negative balances before the end of the school year.
- Students who wish to receive a refund of \$20.00 or more must bring a signed note from a parent or guardian to the cafeteria manager.
- Parents who want to limit their child's spending must send a letter to their cafeteria manager with their child's name and ID number and the amount of their limit per day.
- Drinking water will be available at water fountains at all campuses during each meal service.

#### **Staff/Teachers:**

- The Child Nutrition Manager will provide a list of negative balances at the end of each semester to the principal at their campus. Child Nutrition will make every effort to collect negative balances before the end of the school year.
